Charlene Mizumoto, the Safety Committee and the Essay! By Katharine M. Nohr, J.D.

The following interview was conducted by e-mail with Charlene Mizumoto, chairperson of HAIP's Safety Committee.

Q: How long have you been a Safety Chairperson for HAIP and what does that position involve?

A: I reactivated the Safety Committee in 2002 and have been chairperson since then. The safety chairperson has discretion to do whatever she wants to do. In the past, the Safety Committee was involved with Fire Prevention Week, Project Grad and created a safety calendar.

Q: Please tell us about the writing contest that is conducted every year.

A: We begin the contest by sending a letter to the State of Hawaii, Department of Education (Leeward, Windward, Central and Honolulu) explaining to them the purpose of the contest and request that they provide HAIP with the necessary contact information for each school. Once they approve participation in the contest, each school district provides names of all of their schools, fax numbers, phone numbers and principal's names with the exception of the Honolulu School District which I have contacted numerous times with no response. Using the list provided by the various school districts, letters are addressed to the principals of each school and their English departments in August with strict guidelines to follow. Students can participate on an individual basis as well. The essays are due in October which allowed the safety committee enough time to review and evaluate them and prepare for the December membership meeting.

NAIW has designated December as Drinking and Driving Awareness Month. The safety committee felt that other topics, such as drug/alcohol abuse, drunk driving and speeding also have a tremendous impact on our teens today, and so we expanded NAIW's topic and created our own program. Although it has been suggested that this essay contest be conducted during the beginning part of the year, we wanted the students to become aware of the consequences they face by making the wrong decisions during the holiday and prom seasons when drinking and/or drug abuse may be more prevalent. We are hopeful that by students' writing these essays, tragic incidents can be avoided.

Q: Who is allowed to participate in the contest?

A: It is open to 9th to 12th grade students who attend public schools in Hawaii.

Q: How many entries do you receive?

A: The first contest elicited 40 entries. As the contest has grown, we have received as many as 100 entries.

Q: What are the topics of the essay contest and how long do the essays have to be?

A: Students can write about speeding, drug abuse, alcohol and driving under the influence. They can combine any of the subject issues together. The students are given a strict guideline to follow and points are deducted from the essay if the instructions are not followed. A perfect essay would be 500 words but the safety committee gives a 50 word leeway up or down.

Q: Who judges the essays?

A: Each year a committee is selected to read and grade the essays. The committee consists of those with experience with the grading system and some new members.

Q: What is HAIP attempting to achieve by conducting this contest?

A: We have read in the newspaper of teens dying at such an early age by making the wrong decision in their lives. We are hoping by writing these essays the students will become aware of the consequences of making the wrong decision and/or how someone else's action can impact them as well.

Q: What do the winners of the contest receive?

A: Initially a paper Certificate of Achievement was given and the checks were small for the winning students. The safety committee wanted the students to be better rewarded for their accomplishments and, therefore, changed the prizes to wooden plaques and increased cash prizes to: First Place - \$150; Second Place - \$100; Third Place - \$75; and Fourth Place--\$50. The committee also seeks donations of special prizes for the four winning students and small token gifts for the students who participated but did not win. The Safety Committee feels that every student who submitted an essay should be rewarded for their effort and time.

Q: How do you think the contest impacts the lives of those who enter it?

A: I am not sure what impact it may have since I don't know the students personally. Hopefully, the students that write essays will be more careful in making decisions related to use of alcohol and drugs before driving. A wrong decision can not only devastate their life but someone else's as well.

Q: What motivates you to run this contest year after year?

A: The first winner I had was a student from Waianae. I found out later that he was in a special education class for students with learning disabilities and emotional problems. Winning this essay contest boosted his self esteem. Another student was having family problems. Winning this essay contest helped him through some difficult times and made his family so proud of him. It is rewarding when you touch someone's life just by giving them a little recognition for a job well done. We submit the winners' names to the local newspapers. It is exciting for the students, teachers and parents to see the winners recognized by our organization in the newspaper.

Q: What essays touched you the most and why?

A: Too many, I would have to say. I read all of them before I disperse them to my committee. Many will touch your hearts, give you goose bumps and/or give you an eerie feeling. The students are very descriptive in their writings so I am not sure if they are writing from experience and/or just have creative minds.

Q: How do you think HAIP can improve the essay contest?

A: Each year the committee tries to improve the handling and grading of the essays. It is pretty much down to a "T" now. It would be nice to get more donations/sponsors. The committee wants to give something to all of the students who participated but did not win. It would also be nice to reward the teachers and parents for their support for they have a great impact on the submissions as well.

Q: What other things does the Safety Committee do?

A: We have made unsuccessful attempts at contacting the fire department and police department to see if they need volunteers during Fire Prevention Week. In February, we will be doing a Buckle Up For Love Campaign where baby car seats are donated from HAIP to various hospitals on Oahu. We will be contacting the local hospitals in search of a needy family who needs to have a safe car seat to bring home their new born baby from the hospital.

Q: Is there anything else that you would like to tell the members about the contest or the Safety Committee?

A: Yes, I thank my Safety Committee, because without them the contest could not have been a huge success and I thank the HAIP members for giving me this honor and opportunity to continue as chairperson.

Over 100 public high school students submitted heartfelt stories to the sixth annual Honolulu Association of Insurance Professionals (HAIP) Safety Essay Contest. Their compositions highlighted the devastation to students, families and friends as a result of substance abuse or reckless driving.

Travis Lefrandt of Moanalua High School took top honors for his story about the dangers of crystal methamphetamine. He and second place winner Julia Sungsakris of Pearl City High School, third place winner Sharla Rivera of James Campbell High School and fourth place winner Xenia Ewing of Leilehua High School received a cash prize, plaque and gifts from HAIP corporate sponsors.

"The HAIP Safety Essay Contest is a great way to engage teens on issues that can have long-term effects on their lives and the lives of others," said awards presenter Tim Dayton, GEICO General Manager. "The holiday season is an important time to raise awareness and discourage risky behaviors such as drug abuse and careless driving."
